Acceptable items:

Diapers, Pet Waste & Kitty Litter, Wet wipes, and Sanitizing Wipes, Food wrappers, toothpaste tubes

Non-Acceptable items:

Hazardous Waste, Used Motor Oil, Recyclable items, Compostable Items, Liquids, Batteries, Sharps



ORGANIC-GREEN CART

Acceptable items:

Plants & Flowers, Yard trimmings, Food Waste, Fruits and Vegetables, Shrubs, Weeds, Leaves, Grass

Non-Acceptable items:

Plastics, Glass, Aluminum, Pet Waste Dirt, Rock & Concrete, Metals, Tree Stumps Larger than 6" in diameter



RECYCLE-BLUE CART

Acceptable items:

Junk mail, Magazines & catalogs Newspaper, Aluminum Cans (rinsed) Glass bottles & Jugs (rinsed)

Non-Acceptable items:

No Food Soiled Papers or Containers, Scrap Metal, photos, packing materials, Waxed cardboard, Organic/ Green Waste

- 4. Items must not exceed 6x6x9 dimensions

Sorting Waste is required by law- State Mandate SB 1383

Beginning in January 2022 SB 1383 requires all residents and businesses to have all recyclables and organic materials be sorted out from the trash and placed in correct bins.

The intent under the new state law SB1383 is statewide effort to reduce emissions of shortlived climate pollutants (SLCP)

Effective January 1st, 2022 - Each residence will receive 3 carts for each waste stream-Trash, Recycle, Organics. All trash and Organics carts will be serviced weekly. All Recycle carts will be serviced every other week.

If you request any additional carts, they can be provided at an additional cost per waste stream. To make changes, you are welcome to call our Billing Dept after January 1st at 209-537-8000, press option 3.
